Oral Health Mini-Grant Project

Delta Dental of Colorado Foundation (DDCOF) is seeking applications from Colorado-based non-profit organizations and individuals who aim to improve children's oral health in Colorado. These applications should stimulate the potential for a longer-term project or replication.

Background

Tooth decay is the most common chronic childhood condition and yet preventable. Nearly half of Colorado's 1.2 million children have experienced cavities by the time they start kindergarten. Potential consequences of untreated decay and painful cavities are lower GPA, more missed school days as well as behavioral problems. There is interest in exploring different innovative ideas and projects that could expose communities to the importance of children's oral health.

DDCOF is improving Colorado's dental health by working to eradicate childhood tooth decay. By supporting projects that increase access to care and address the causes of the disease and impacting systems, we have a unique approach to fighting childhood cavities.

DDCOF works to:

- Reduce tooth decay in Colorado's children
- Fund educational programs that teach good dental habits that target low-income, high-risk children and families
- Support efforts to integrate preventive dental care into medical practices
- Support dental health education for higher education students and providers in a variety of medical fields
- Promote community awareness and focus on prevention
- Highlight the importance of good dental health for pregnant women and children

Mini-Grant Overview

DDCOF is seeking applications from individuals or organizations statewide to design and implement a project that targets one of our drivers of success:

- Increase the public's awareness of and support for oral health
- Improve access to evidence-based dental care
- Secure decision makers' buy-in to the importance of oral health

Projects that are longer than 7 months will require an interim status report halfway through the grant period.

Priority in the selection process will be given to applications that:

- Show innovation
- Describe the implementation plan
- Have the potential to become sustainable
- Reach underserved children

Sample Concepts

DDCOF will consider funding unique project applications that integrate oral health and into the community. Concepts that might be funded include:

- Projects that focus on early dental care through one-to-one or small group oral health education with parents of infants o-12 enrolled in a program (like WIC)
- Give Kids a Smile day transportation costs
- Classroom activity kits for early childhood education centers
- Efforts to increase dental visits among the underserved
- Oral health education for direct care providers
- Dental home projects
- Public-private partnerships that establish programs
- Behavior change efforts that promote drinking water and educate about the negative affects of sugar on oral health

Funding

As part of an abbreviated grant application process, those who wish to apply must illustrate how the project will improve children's oral health. Approximately \$100,000 is available to fund grants through this project. Grant funding amounts will vary between \$1,000 and \$15,000 per organization/individual. The dollar amount per grant will be based on merit as determined by the mini-grant committee.

Applications may include requests for funding projects that take up to one year to complete. Funding is also available for a one time use. The project team can answer questions during the application process.
