Initiative to build public support for behavior change and lead to deeper public understanding and prioritization of oral health as a health care issue. This program provides key messages about the importance of children's oral health through mass media and grass roots activities designed to lead to better individual oral health behaviors and stronger public policy regarding oral health.

4b (Code:) (Expenses \$ 624,816. including grants of \$ 434,712.) (Revenue \$)
Grants to organizations that increase access to preventive dental care, prevent oral disease through increased education and system collaboration to build the connection between oral health and physical health.

4c (Code:) (Expenses \$ 565,466. including grants of \$ 369,482.) (Revenue \$)
The Colorado Medical-Dental Integration Project adds preventive oral health services provided by dental hygienists into primary care medical settings. The foundation aims to reach families who have limited access to dental care due to location, insurance status and transportation issues. Hygienists placed in medical clinics throughout the state provide oral health care and make referrals to local dentists when further treatment is necessary. The foundation has funded 26 medical clinics through the Colorado Medical-Dental Integration Project. Wave II of funding for the project was appropriated in 2017.
